

The Palm Desert Area Chamber of Commerce has designed the Emerging Leaders Program with our next generation leaders in mind. Our mission is to help participants develop and strengthen skills in the following key areas:

- **Communication:** body language, verbal communication, presentation skills, active listening, interviewing, and more.
- Leadership: strategic planning, team building, giving feedback, decision-making, and more.
- **Personal:** self-leadership, professionalism, adaptability and emotional intelligence.
- **Professional:** organization, planning, scheduling, time management, business etiquette, ethics, writing and resume preparation.
- Interpersonal: networking, conflict resolution and relationship building.

Through interactive presentations, panels, guest speakers, and behind-the-scenes business tours, participants will gain valuable opportunities to practice these skills and connect with community and business leaders.

The Emerging Leaders Program will convene on the fourth Friday of each month from January through June 2026, except April and June. Sessions will run from 9:00 a.m. to 4:00 p.m. The following dates require participant attendance:

Cost: \$50 enrollment fee*, due January 23, 2026

Scholarships are available to help cover the fee for those who may need assistance.

Participation Guidelines:

- Applicant must be a current student at a Coachella Valley accredited university/higher education institution during the 2025-2026 academic year.
- Applicant must be in good academic standing with a 2.5 GPA or higher.
- Applicant must be committed to attend all six sessions. One unexcused absence will result in being dropped from the program. A maximum of two excused absences is allowed.
